

GENERAL INFORMATION AND SAFETY INSTRUCTIONS

To ensure Your safety during Your stay in the port, please, pay attention to the following general information:

- All area within the gate and fence is an ISPS (International port facility security) area.
- Please, pay attention to the cargo handling vehicles and cranes in the port. The visibility from machines and cranes are restricted. Do not go near them during operations.
- Never enter a cargo hold or walk below a crane during operations. If it is necessary, ask for permission from foreman or stevedoring crew.
- Visitors are not allowed to enter other areas than the official roads of the port without permission.
 If You necessarily need to drive alongside to a vessel, ask for permission from foreman or stevedoring crew.
- Always use high visibility clothing, safety helmet, safety goggles and safety footwear within port area or other areas related to the port.
- Hot Work permission is needed whenever hot works will be carried out on shoreside. Permission to be applied from nominated ship Agent, Port Office, or Stevedores Office. The person carrying out the hot work, will also need to have a valid Hot Work Certificate.
- Smoking is prohibited in areas where combustible substances are stored. Smoking inside any building, warehouse, crane, container etc. is also PROHIBITED.
- More information in the waste management guidance.
- Other Services such as fresh water to be ordered from nominated ship Agent or Port Office
- Vessel must use gangway.

GANGWAY

- A safety net must be fitted under the gangway, extending 2m on both sides!
- Gangway must be lashed/tied to the vessel!



- If necessary, use platform/ladder/steps between gangway and deck for a safety access!
